ORDINANCE NO. 091211

AN ORDINANCE ESTABLISHING A FEE TO RECONNECT WATER METER FOR WATER SERVICE

WHEREAS, the City Council of the City of Shawneetown, Gallatin County, Illinois has determined that it is necessary and proper for the City to charge a fee to reconnect water service to a water customer's home or business when the service has been disconnected for whatever reason; and

WHEREAS, the City has determined that if the customer was disconnected for nonpayment of a bill or delinquencies, prior to restoration of water service, the fee to reconnect water service shall be paid in addition to the payment of all delinquent and past due bills for water service as determined by the appropriate City official (City Clerk or Utility Clerk); and

WHEREAS, this reconnection fee is intended to minimize financial loss to the City and to partially cover operational costs of staff time in making such reconnection;

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF SHAWNEETOWN, GALLATIN COUNTY, ILLINOIS, AS FOLLOWS:

1. The fee to reconnect water service following disconnection of water service for whatever reason shall be Seventy-five Dollars (\$75.00). If the service was disconnected for nonpayment of a bill or delinquencies, prior to restoration of water service, said fee shall be paid in addition to the

payment of all delinquent and past due bills for water service as determined by the City Clerk or Utility Clerk of the City of Shawneetown.

2. All other provisions of prior water rate and usage ordinances heretofore adopted, shall remain in full force and effect, except to the extent as amended herein.

3. This Ordinance shall be in full force and effect from and after its passage, and publication, if any, as required by law, and shall take effect immediately.

4. This ordinance shall be published in pamphlet form and made available for distribution to the public, generally, and the Clerk is directed to maintain a full copy of such ordinance on file for the use and examination of the public, immediately hereafter.

WHEREAS, this reconnection fee is intended to minimize financial loss to the City and to partially cover operational costs of staff time in making such reconnection;

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF SHAWNEETOWN, GALLATIN COUNTY, ILLINOIS, AS FOLLOWS:

1. The fee to reconnect water service following disconnection of water service for whatever reason shall be Seventy-five Dollars (\$75.00). If the service was disconnected for nonpayment of a bill or delinquencies, prior to restoration of water service, said fee shall be paid in addition to the

payment of all delinquent and past due bills for water service as determined by the City Clerk or Utility Clerk of the City of Shawneetown.

2. All other provisions of prior water rate and usage ordinances heretofore adopted, shall remain in full force and effect, except to the extent as amended herein.
